INTRODUCTION

The Cumbria Cultural Fund was established in 2005 by the late Mary Burkett, who was passionate about providing opportunities to people, and from a range of backgrounds, to develop skills and realise their ambition in the arts.

Cumbria Community Foundation is seeking new Advisory Panel Members who will oversee distribution of grants from the Fund and be ambassadors for the fund and its development. We would like to recruit a diverse panel that is representative of the Cumbrian arts and cultural sector/community and that represents a variety of backgrounds, perspectives and skills.

ABOUT THE CUMBRIA CULTURAL FUND



The Cumbria Cultural Fund was established to assist people "striving to reach the highest levels of achievement and excellence in their chosen field of the arts".

Mary believed that everyone has the capacity to succeed in the arts if the right support is provided, along with individual commitment and determination. Her overall aim was to support people to achieve high standards and excellence, when possible, in their chosen field.

Although her focus was the visual arts, she had eclectic tastes and interests; therefore, the fund is open to applications covering a broad spectrum of existing and emerging arts and cultural activity and from people at differing stages in their journey.

Applications may be made from individuals living in Cumbria. While awards are generally for no more than £500 over any one year, there is no minimum or maximum award. Successful applications are likely to be to individuals forming a portfolio of financial support.

Since 2015, more than 40 people have received a share of £38,000.

GROWING THE CUMBRIA CULTURAL FUND

The Cumbria Cultural fund was created by Mary with her financial support and with donations from her wide network of friends. It is the ambition of the Foundation to grow the fund to support individual achievement in the arts and cultural activity with the significant direct and indirect benefits this offers.

The fund is open to donations which are then invested; to enable continuation of grant making to individuals from Cumbria who wish to pursue a career within the creative arts and/or culture.


KEY RESPONSIBILITIES

- Promoting and advocating for Cumbria Community Foundation and the fund actively via your networks to encourage applications and donations and drive new visions and values forward.
- Act as an enthusiastic ambassador for Cumbria Community Foundation and the Cumbria Cultural Fund.
- To act as a listening post in order to provide any information which may be of assistance to Cumbria Community Foundation and the Cumbria Cultural Fund.

Cumbria Community Foundation seeks to build diversity across its board, committee and panels and its staff team, and consideration is given to ways in which groups that are under-represented might be reached and encouraged to apply.
